

## From Founder and Executive Director James Zeigler:

This year I will be stepping down as Executive Director of The Second Look Project, the organization I founded almost 5 years ago and which has been the high point of my career as a criminal defense lawyer. I am deeply proud of the work we have done in this time and the incredible staff we have developed, grateful to so many of you for your support of our work, and most of all to our clients for their incredible resolve and willingness to place their trust in me and our organization.

This announcement comes with a mix of sadness and excitement for me. I am so proud of what The Second Look Project has accomplished since its founding, but after nearly 10 years of indigent defense and postconviction practice, and as a father to two young kids, I am no longer able to give this job this all the emotional and mental energy that it demands. The time has come to move on, both so I can prioritize the things in my life that are most important to me, and so the organization can have the best and most committed leadership possible.

This is also an exciting time for SLP, as it looks towards the next phase of its development and continues its mission of bringing people home from extreme sentences. I will continue to serve as the organization's Executive Director as it searches for its next leader, and will do all I can to facilitate this transition.
